



**Please provide the following information when applying for an Oversize and/or Overweight hauling permit from either ODOT or a Local Jurisdiction.**

**Note: If you or your company does not have an account with ODOT, you must have your Insurance Company file an OS-32 form with ODOT (the OS-32 must be sent directly from the insurance company or authorized insurance agent to ODOT.) There is no cost to open an account. Once an account has been established we will be able to apply for permits for you.**

ODOT will issue Overweight Permits at a GVW of 120,000 lbs. or less for periods of:  
 5-Days (Single Trip),  
 90-days (Unlimited # of Trips)  
 or 365-Days (Unlimited # of Trips).  
 For vehicles with a GVW in excess of 120,000 pounds, a 5-Day permit is the only option.  
"Michigan Legal" permits are an exception to the last sentence but are only valid in Williams, Fulton and Lucas counties.
